## Delaware Awarded 2016 ESC Energy Stewardship Award

August 11, 2016: ESC President Tom Walther, presented the first ESC Energy Stewardship Awards to 10 states at the 5th Annual Market Transformation Conference. Awards. Delaware was recognized for a combination of state's leadership, programmatic design, and the amount of private sector investment in guaranteed energy savings performance contracting in the state.

The conference agenda included panels covering programs and incentives for Delaware businesses, energy resiliency, and emergent technologies.

# Delaware's Guaranteed Energy Savings Agreement

October 24, 2016: Delaware officials unveiled plans designed to reduce energy costs at National Guard facilities around the state. The 20-year plan, called a Guaranteed Energy Savings Agreement, is expected to cut fossil fuel consumption at the facilities by 38 percent and save the Delaware National Guard \$6 million in energy costs over 20 years. It is being funded through a loan from the Energize Delaware's Revolving Loan Fund program.
